

# WHERE DOES YOUR TAX DOLLAR GO?




The municipality is responsible for collecting property taxes and dispersing your money to our **local school, county, municipal open space fund, and the fire district**. If property taxes are not paid, the town must still fund these entities.

#### Tax Rate Breakdown – 2013




#### 2014 Revenue Sources



#### **Fund Balance Usage**

**2014 Usage = \$966,022** 



#### 2014 Revaluation

- $\square$  2013 Ratables = \$1,934,959,045 (111% of FMV)
- $\square$  2014 Ratables = \$1,591,367,241 (~100% of FMV)
- □ 2013 Value of Average Assessed Home \$283,500
- □ 2014 Value of Average Assessed Home \$231,700

## Impact of the Proposed 2014 Tax Levy on Average Residential Taxpayer

- □ Value of the Average Cinnaminson Home = \$231,700
- □ 2013 Municipal Taxes
  - Municipal Tax Rate 2013 = \$0.460
  - $\blacksquare$  Cost for local services in 2013 = \$1,304.27
- □ 2014 Municipal Taxes
  - Proposed Tax Rate 2014 = \$0.585
  - Increase in Tax Rate = 12.5 cents ~2.1 cents
  - Cost for local services in 2014 = \$1,356.06

#### **How Will The Tax Increase Effect Me?**

- Increase in cost to the Average Home Owner
  - □ \$51.79 per year
  - □ \$4.31 per month
  - □ \$0.99 per week

  - Maintenance of the roads


### What do you get for \$1,356.06?

  - Animal Control


#### 2014 Budget Highlights

- Appropriation Highlights
  - Hiring two new police officers
  - Budget includes a \$100,000 Reserve for Tax Appeals
  - Healthcare increased 6.6%
  - Retro pension payment
- No school tax deferred
- No more accelerated tax sale


#### 2013 Line Item Appropriations
