

**CINNAMINSON TOWNSHIP COMMITTEE**  
**May 2, 2016**

The Regular Meeting of the Township Committee is being held at 6:30 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077. This meeting is being held in accordance with the "Open Public Meetings Act," P.L. 1975 c.231, having been advertised in the Burlington County Times on January 5, 2016.

Mayor McCarthy opens the meeting with the Pledge of Allegiance

Moment of silence in remembrance of Bob Coates, a member of the Fire Department for 10 years and Pat Schaefer, a longtime resident who worked at the County Clerk's office.

Presentation from Riverton Country Club, Michael Rudon regarding fireworks for 4<sup>th</sup> of July. Event will be June 30<sup>th</sup>. It will be virtually identical as last year. This will be a private event. We do expect that people will gather around the property to observe it. It is not open to the public; we are not selling tickets to the public. We do not want this advertised as a public event. The Country Club will cover all costs. There will be no cost to the Township. We will notify local residents, mailings will be expanded.

DIRECTOR KING: The same no parking rules as last year will be in effect.

MR. BRAUCKMANN: How will it be handled when the public becomes aware of it?

DIRECTOR KING: It is a private event. If it's not overwhelming we will not use police to move them. If it becomes a problem then we will use police. We're going to do everything we can to not site people.

MR. RUDON: Within the comfort of your department we would tolerate people on the fairway and rough areas.

MR. MINNITI: I think you are making a big mistake, not with the event but with this wink, wink, it's a private event. You are going to have more people because the word is it was a great event last year. We don't get involved in saying yes or no. We take a step-back approach and leave it to Mickey and Danny to coordinate this. There has to be a better method for establishing a perimeter and keeping residents from flowing into the Country Club. I think you have to create the impression that you can't just walk onto the Country Club property.

MR. RUDON: In addition to the police we will have our crew going around the perimeter as well.

MR. MINNITI: If people start parking at the high school and start walking in between the homes, if it starts you have no way of stopping it.

MR. RUDON: We are in no way encouraging that.

MR. MINNITI: I know but you're not discouraging it either. You need to have something that keeps the potential crowds from pouring in. I think you have to present some sort of plant that is meant to keep people off of the property.

MRS. FITZPATRICK: I want to know if you, your staff and your board members have spoken about potential damage on the course from people. Because really at the end of the day it's your property. What do you think about it?

This is a private event. The police can handle along with the Country Club staff. Make sure you do a good job of notifying the neighbors, possibly expand the list from last year.
