

## CINNAMINSON TOWNSHIP COMMITTEE

**July 16, 2018**

The Work Session Meeting of the Township Committee was called to order by Acting Mayor Brauckmann at 6:30 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077.
