The parks crew has been out and reconstructed the baseball field at East Riverton Park and was also able to prep Memorial and Wood Park for the baseball and softball opening days. Also on May 19, 2018 between 8:00 am and 2:00 pm Public Works will be open to accept paints, motor oil, tires, TV's, auto batteries, large trash items, metal items, electronic items, brush and tree branches, fluorescent bulbs and four foot tubes.
