Comments from Mayor and Committee

MR. BRAUCKMANN: Thank you all for coming tonight and I wish everyone the best in the coming new year. The first thing I'd like to do is congratulate Bud Evans and welcome him to township committee. Bud has a very impressive background and I feel he will serve Cinnaminson not only well as a committee member but as a liaison to departments that are well commiserate with his unique skill set. Based on his prior police experience, his current service as an officer in the PA Air National Guard and his education background including a bachelor's degree in finance with a master's in business administration I see Bud providing valuable input to our police department, our administration and finance departments as well as to this committee in regard to how we conduct ourselves as your elected officials. He is an outstanding addition to this committee and I look forward to working with him for many years to come. Congratulations Bud. In Cinnaminson we're gaining an outstanding representative with the addition of Bud Evans, but we also lost a great one with the departure of Kathy Fitzpatrick. For nine years Kathy has served as a true representative of the people. She always listened to the people of this community and always fought hard to protect their interests to make sure that their voices were always heard. As a person who served as an infantry non-commissioned officer in the US Marine Corp and as a twenty-four-year veteran of the police department and now as I start my tenth year as an elected official I've seen all kinds of leaders. Something I've learned over the years is that the best leaders govern from the trenches. That is exactly what Kathy did. Kathy's strength was that of a true representative of the people because she knew our residents well and they communicated not only to her but through her. Her passion to serve the residents and to speak on their behalf was what guided her. She was the epitome of people before politics and she was never meek to speak on the people's behalf. As an elected official the last presidential election was very inspiring to me as many of you know. The first one was taking care of America and Americans first and this related to me directly because I am a firm believer in Cinnaminson first above all else. It should always be our residents, our schools, our other elected boards, our sports organizations, our volunteers and our businesses first and foremost. All of these things should always be first in our mind and should always get priority out of any out of town group, business or person. Something else that really related to me as a personal belief of mine, it so inspired me that someone finally brought it up. It might not be popular especially with politicians. Personally I believe that no one should ever serve one office more than twelve years. As an elected official myself going into my seventh year I can promise you all tonight that regardless if any of these term limits are ever imposed or not, that's my personal standard and I promise that I will never serve one office more than twelve years. The final thing that I thought was really inspiring to me was that the nation felt what I was feeling. People finally

have had enough of politics as usual and they finally took their government back. In order to feel this way people need to have their finger on the pulse of the people and know what the people want. Many in politics aren't properly connected to the communities they serve anymore and lose touch with their residents so they don't always seek their input anymore. They become too empowered. This also ties in with the reasoning behind my thinking of term limits but also with the belief that the silent majority is watching us and will always take back their government when they feel their government no longer represents their interests. The last election should serve as a wakeup call to everyone. So I hope people, especially elected officials, at all levels, were watching and paying attention so government can properly return to one of "we the people" the way our founding fathers originally intended it to be.

As always I want to give thanks to all the people that help me to do what I do as your liaison to Parks and Recreation. Last year as we do every year we coordinated our summer concert series, Cinnaminson Day, Trunk or Treat, Christmas tree lighting ceremony, our senior's Christmas dinner, summer tennis lessons, summer basketball and also adult exercise classes and senior dance classes. We also coordinate the permit process which governs the use of all township parks for all of our sports organizations. Since we do not have a paid Parks and Recreation director or full time paid staff like many surrounding towns have, I rely heavily on many others to help pull off the things that we offer here in Cinnaminson. I have to thank our volunteers, some of the people in Town hall that help me and of course the other members of this Township Committee who are always supportive of the things we do at Parks and Recreation to provide services to our community. Other key players are our volunteer advisory board, Pat Rucci, Christine Turner, George Ferris and many others including our Public Works Department who is always there to provide the things that we need. If I missed anyone I apologize.

I want to thank Mickey King for doing a great job with all the jobs he does for our Township. I'm not sure if everyone is aware of this but he is our administrator, our public safety director, community development director and also by default our acting Public Works Superintendent. Although he is doing an outstanding job and it's commendable by filling all of these positions it is my hope that this year this governing body takes steps to fulfill and fill a couple key vacancies to spread the management of our township among a group of department heads who will report directly to Administrator King which I personally feel is a far more effective way to run our organization. The first priority I'd like this committee to take is to fill the position of Public Works Superintendent. That position has been vacant for over two years. This is something I'd hope we would re-advertise for and fill as soon as possible. The other thing I'd like this committee to consider is to establish a timeline to convert our police department back to one that is led by a chief of police and not a public safety director. I'm not sure what that timeline would be and it could be a couple years from now. But our police department is functioning at such a high level with Mickey King right now I understand that might be down the line but I want us to start thinking about that. Because the decision to do that and to convert to a public safety over a chief more than three years ago was never meant to be anything more than temporary. This will allow our police personnel to get prepared and properly trained to ultimately lead our police department again. Hopefully this committee will take these two steps to fill these key positions which will give us a full complement of leadership staff to effectively manage our township for many years to come.

In closing I'd like to thank all of our sports organizations, community groups and other elected governing bodies in Cinnaminson, that being our school board and fire commissioners. And of course all of our township employees at town hall, public works and our police department. All of these groups or individuals work tirelessly for Cinnaminson and take seriously their responsibility to always do what is best for Cinnaminson. We are a lucky community to have such great people and such great residents. I look forward to working with this committee to make it an even better 2017.

Last but not least I want to thank my wife, Michelle, and my children for always supporting me for doing a job that I love doing which is being your voice here in Cinnaminson as your elected representative.

Thank you all for listening, thank you for your continued support. God bless you all and Happy New Year. Thank you Mr. Mayor.

These efforts do not go unnoticed. National Night Out at Memorial Park was a great event. Along with Cookout with the Cops and Breakfast with Santa, these are the types of community events which make Cinnaminson very special. Thank you to the Cinnaminson Police Department.

As always, I don't think Jim's here but I'll still thank Sea Box and my coworkers for covering for me on those days when I come in late, leave early or take an extra-long lunch to take care of a few things.

To my neighbors and the residents of Cinnaminson thank you for your support. You're what make Cinnaminson a great town. As always we invite you and encourage you to attend our meetings, visit our website, use the information on it. Think about getting involved. Feel free to introduce yourself to me around town. Email us or call the township building when you have a problem or concern. We'll respond to your concerns. We have a great team and we'll do our best to solve your problems.

Thank you to my fellow committee people for your support over the years. Tony and Ben your knowledge and commitment to this town is acknowledged and greatly appreciated by this committeeperson. As I mentioned before Tony is on the Economic Committee and he is doing a great job. Ben thank you for your efforts with Public Works the past few years. The Public Works employees do a great job for this town. Special thanks, congratulations and recognition should go to the public work employees and especially the supervisors John, Scott and Mike.

Don, as always you do a great job with Parks and Rec. This year's events among others, the summer concerts, the movie nights, the Christmas tree lighting were all great successes. Congratulations.

Unfortunately, over the last year and a half we've had a few hiccups, mostly to do with our Park and Rec ordinance. But Don, I'm confident that with your leadership you and the subcommittee will work out these issues very soon.

I've served on the Planning Board this past year to fill a vacancy and also attended a number of Zoning Board and Sewer Authority meetings and can truly appreciate the effort of the individuals who serve our community. These mostly volunteer positions are the backbone of this community. And to those who serve, your willingness to be involved shows that you care about what is happening in our town and that is greatly appreciated. Thank you all.

I also want to thank both the Fire service and our police for their support at the various functions we've had over the year. I also thank them for the support that they have given for the yellow ribbon events that have happened in Cinnaminson this past year. Remember people, when you see many of them at the special events they are not on the clock, but are there of their own interest in the community.

I again want to recognize our Department of Public Works. While we continue to operate short-handed, their attitude is terrific. They do a great job with their existing resources. We have supervision in this department that is available whenever we need them. They make sure we have contact info if they are away. I can and have reached out to them at literally all hours and they have responded. It continues to be my privilege to represent this department. Guys – Thanks for the continued great work and the positive attitude.

Most importantly, I want to thank my family; Connie, my wife, partner and best friend, who continues to provide both her counsel and support and keeps me grounded, along with our sons, Bill, Greg and Jeremy, without whose help I would never be able to serve on this Committee.

To all of you, the best of the New Year. Thank you.

MAYOR MINNITI:

Before I begin my comments, I'd like to join my fellow Committeemen in congratulating Bud Evans on his election and welcoming him to Township Committee. He's a hard worker who possesses a diligent and enthusiastic approach to service. This Committee and community are fortunate to have him. I would also like to thank my fellow members of Township Committee for choosing me to serve as Mayor this year. I'm honored to have earned your trust and look forward to leading our town through what promises to be a very challenging, yet exciting year.

Before I began preparing this evening's comments, I spent some time reading my speeches from past years. That's when it really "hit home"; the realization that this is my 15th re-organization. Each year my comments seemed to speak about the challenges our town was going to face, or celebrated goals that we met. But the common thread in each speech was how proud I was of our town, and excited I was about our future. I always believed that the true measure of our success as elected representatives was fairly simple; Is Cinnaminson a better place because of our efforts. By this measure, I'm as optimistic as ever that it is.

I believe that we on Township Committee are probably given too much credit for the successes (and too much blame for the setbacks) of our town. That said I do believe that we play a very important role in establishing high standards of service; where we strive to make Cinnaminson the best it can be. Township Committee should serve as the example by which all who volunteer, work, or serve our community can look to. Cinnaminson is successful because of the many residents who volunteer to serve in many different capacities; From our School Boards to our Home & School associations and PTAs. To the hundreds of parents who organize, administer, and coach our robust sports programs or serve in our community based religious institutions. To the volunteers who plan the activities so many residents enjoy, or who rally our community to the aide of fellow residents who've experienced personal tragedy or loss. To those who serve on our Township Boards, Fire District, and Sewer Authority. And to all those who work serve us each day as police, firefighters, in our public works departments or in Town Hall. Our success as a community is because of our shared commitment to making our town the wonderful place it is.

Cinnaminson's standing as one of the region's most desirable communities is due to all of our efforts and I'd like to both thank and recognize all for their work.

Another common thread in my speeches has been, of course, a focus on economic development and how important it is to our town. 2017 promises to mark the beginning of another transformative era for our Route 130 corridor. Mayor Mike Minton's addition to our economic development team has proved invaluable. In the past year, Cinnaminson has approved two major re-development projects (Wawa with gas) at both our north and south ends of Route 130. The long abandoned Dynatec factory is finally seeing new life as a Conoco Gas Station and car wash. Approvals are pending for new businesses to occupy spaces in our existing centers and we're making continued progress in our attempts to redevelop the few remaining outmoded uses and vacant properties.

A very important, yet somewhat unnoticed infrastructure project will begin in the coming year. The Cinnaminson Sewer Authority will begin installation of sewer main down Taylor's lane. Lack of sewer service has been a major impediment to our ability to attract business, both to the Route 130 and Industrial properties serviced by this roadway. I would like to extend our thanks to the authority for agreeing to assist us by making this very important investment.

A final observation I made about my past comments is that they probably go on a little too long, so I'd like to end by expressing a few words of thanks; To my wife Rose, who continues to not only tolerate, but support my desire to serve, I couldn't do this without you. Making the round trip from Scranton to Cinnaminson to be here tonight? I think that says it all and it means everything that you're here for me.

To our kids, Amanda and Jess, and John, Christian and Claire, thank you for your understanding and willingness to share your already limited time with me. I hope I can make you as proud of me as I am of you. To the Cinnaminson Republican Organization who works so diligently to find and motivate people to serve. They continue to set the standard for "good government", as they have for decades.

But most of all, I'd like to thank you, my fellow residents. I made a promise during my very first campaign back in 2002, which seems so long ago now; that I belonged only to you and would continue to serve as long as you would have me. 5 elections and 15 years later, it's hard to put into words, how much it means that you continue to choose me to represent you. You express appreciation when you think I'm doing the right things, and you don't hesitate to let me know when you think I'm not, and I'm thankful every day for both.

Comments from the Public

Chief William Kramer, Cinnaminson Fire District - Congratulates new committee member Bud Evans. Comments regarding new proposal for EMS services and disappointment that the Fire District was not allowed to do a presentation to full committee.

Mayor Minniti responds that this matter was handled by a subcommittee who worked on it for a year.

Director King comments that based on his 36 plus years of law enforcement and public safety he would never make any recommendation that was not in the best interest of the community. If there was that much money to be saved, he would bring it under the Division of Public Safety rather than the Fire Department.

Mr. Young states that this decision was not done lightly and with a complete review of its history. This has been a pay for fee service. We have Palmyra Ambulance. They accept whatever the insurance company pays vs. if there is a shortfall with the Fire District the taxpayers would have to pay the difference because someone has to fund the department. The existing service is of no cost to the taxpayers. There were two meetings with the subcommittee and the organizations involved.

Mayor Minniti restates that from a public safety standpoint there is not a compelling reason to risk a change to make something better that is already working well. From a cost perspective this is a free service so therefore there cannot be a tax savings. The Township has no risk, no responsibility and no role other than to spell out our requirements. If we opened this up we would be required to put out to bid to all fire departments, all EMS squads and hospitals that offer EMS services. The Township has approved an agreement for one year that we can review annually. The agreement effects our neighboring towns, Palmyra and Riverton which could damage our relationship with these towns.

Mr. Brauckmann comments that he would like to have a discussion with other elected bodies and Palmyra ambulance. He has never seen formal proposals but would like to. It is a creative way for the fire department that as a taxing authority to generate revenue to offset a fire tax increase.

Mayor Minniti states that we work until the end of the year. This issue needed to be addressed. The solicitor advised that the agreement should be in place or we would be exposed.

Karen (unable to understand): Concerned with response time. Every minute counts. What is our average response time? She is concerned with the response time.

Committee confirms that it was looked into by the subcommittee.

Director King responds that under the agreemen in Cinnaminson which has been done since Octo	t with Palmyra squad they have to staff a 24/7 ambulance ober 1st. You also get police and fire response.
