### **Liaison Reports**

Parks and Recreation-Mr. Brauckmann

Mr. Mayor, for my parks and recreation liaison report I have the following to offer: Despite the tough weather and typical late winter we're experiencing, our parks employees are doing an outstanding job trying to get our fields ready for spring sports. They are also still cleaning up from the devastating storm that hit us on March 7th. As the liaison to our sports groups, on their behalf as well as township committees, I want to commend Mike McDonald and the other public works employees for the job they do. You guys are great. It is much appreciated.

Spring Sports start in early April so I just want to wish all of our sports boards, coaches, parents, and young players a great season. Mr. Mayor, this concludes my report.

I talked to Christine Turner. This weekend's park cleanup is postponed due to the expected bad weather. A new date will be announced shortly.

#### Public Works - Mr. McGill

Thank you Mr. Mayor. According to Superintendent Todd Day, during the last week of February and to date in March, DPW has worked on the following: The biggest thing has been the March 7<sup>th</sup> storm when we removed fallen trees and limbs during the storm. We plowed all night to have the roads cleared by 3:00 am on the 8<sup>th</sup>. This work was performed by the entire crew. Since then we have taken down additional fallen trees and limbs. Processing of leaves and limbs continues in the brush yard on a daily basis. Brush pickup started on 3/5 but was delayed due to the storm. Three crews worked all day on Saturday to catch up. They had a few days of filling potholes. They are continuing cleanup and inspection of the 1500 plus drainage inlets throughout town. The park crews are focused on getting the fields ready for spring sports and cleaning up the parks from the storm. That concludes my report.

# **ORDINANCE 2018 – 3**

# AN ORDINANCE AMENDING CHAPTER 381 OF THE TOWNSHIP CODE OF THE TOWNSHIP OF CINNAMINSON ENTITLED "PARKS AND RECREATION" AND MODIFYING THE FILING REQUIREMENTS CONCERNING FILING FEES FOR APPLICATIONS FOR SEASON-LONG SPORTS EVENT PERMITS AND THE USE OF MUNICIPAL PARKS FOR PROFIT-MAKING VENTURES

**WHEREAS,** consistent with the Garden State Preservation Trust Act, N.J.S.A. 13:8C-1 et seq., the Township Committee of the Township of Cinnaminson owns and maintains municipal parks for recreation and conservation purposes; and

WHEREAS, Chapter 381 of the Municipal Code of the Township of Cinnaminson establishes regulations concerning permissible activities for the Township's parks and to further the public health, safety, and general welfare of its residents and other members of the public wishing to utilize the Township's parks; and

WHEREAS, in accordance with promoting the Township's general welfare and promoting the productive and beneficial use of parks the Township Committee of the Township of Cinnaminson has determined that it is in the best interest of the residents of the Township of Cinnaminson and the members of sports organizations and teams to eliminate unnecessary regulations that undermine the purpose of Chapter 381 of the Municipal Code of the Township of Cinnaminson; and

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Cinnaminson in the County of Burlington, State of New Jersey that Chapter 381 of the Township Code be and is hereby amended as follows:

**ARTICLE I: AMENDED SECTION.** Chapter 381, Section 8, Subsection (C)(1) of this Code is hereby amended and as follows:

1. In addition to the above permit fee, each organization and/or sports team shall pay a nonrefundable, annual application filing fee of \$250.00.

# ARTICLE III: Repealer, Severability and Effective Date.

- 1. **Repealer**. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- 2. **Severability**. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- 3. **Effective Date**. This Ordinance shall take effect upon proper passage in accordance with the law.

# **ORDINANCE 2018 – 4**

# AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 265, SECTION 7 OF THE TOWNSHIP OF CINNAMINSON'S MUNICIPAL CODE, ENTITLED "CONSTRUCTION CODE FEES"

**WHEREAS,** the New Jersey State Construction Code Act, N.J.S.A. 52:27D-119 to -141, and the regulations set forth in the New Jersey Uniform Construction Code, N.J.A.C. 5:23-1.1 to

-12A.6, are purposed to implement uniform construction standards and enforcement policies and practices throughout the State; and

**WHEREAS,** N.J.A.C. 5:23-4.18 requires municipalities to set a flat fee for mechanical inspections performed by a licensed mechanical inspector or plumbing inspector for certain structures; and

**WHEREAS,** Chapter 265, Section 7 of the Municipal Code of the Township of Cinnaminson establishes fees for the Township's Uniform Construction Code; and

WHEREAS, the Township Committee has determined that it is necessary to update and revise its construction code fee schedule to include fees for mechanical inspections in compliance with the State requirements; and

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Cinnaminson in the County of Burlington, State of New Jersey that Chapter 265, Section 7 of the Township Code be and is hereby amended as follows:

**ARTICLE I: AMENDED SECTIONS.** Chapter 265, Section 7 of this Code, entitled "Construction Code Fees" is hereby amended and supplemented as follows:

§265-7(A)(5) is hereby amended and shall read as follows:

"Whenever the Township is called upon for a mechanical inspection of a group R-3 or R-5 structure by a mechanical inspector, the corresponding fees shall be as follows:

Type of Inspection	Fee
First Device (furnace or boiler)	\$82.00
Each additional device	\$25.00
Water heater	\$20.00
Oil or LPG tank	\$46.00 per tank
Pre-fabricated fireplace, gas piping or fuel oil piping	\$46.00
Minimum fee	\$46.00

1. §265-7(B) remains unchanged.

# **ARTICLE II. Repealer, Severability and Effective Date.**

- 2. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- 3. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- **4.** Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
