As everyone knows the new trash collection schedule has started as of last week. Public Works has hired a temporary secretary who started today. This person is helping us keep pace with any questions or requests regarding the new trash collection and trash cans.

Pennoni, the Township engineer has reported that the new duckbills are arriving shortly for installation. We anticipate having another drainage subcommittee the first week of February to review progress and discuss next steps.

Alaimo Group anticipates having the Wayne Ave. Bridge recommendations to award a contract the first week of March 2020.
