Ben Young, 116 Woodview Lane – He believes Taylors Lane intersection is a mess and needs a left turn signal. Mr. Minton commented that the Township is aware of it and that it may not be the cost but it may be that DOT wants to hold the green time on Route 130. He also asks that Woodview Lane be put back on the list for repaving. It is a main thorough fare to get to the middle school.
