

Affordable Housing Program Market To Affordable For Sale

Pre-applications are currently being accepted to be added to the waiting list to buy affordable units in Cinnaminson Township. In order to be eligible for an affordable housing unit, you must meet certain income limits as determined by the New Jersey Affordable Housing guidelines.

Initial units are expected to be ready for occupancy in 2021. Interested households will be required to submit a pre-application in order to place your name on a waiting list.

Applications will be accepted until Thursday, February 18, 2021 at 5pm to be included in the lottery drawing that will take place on Friday. February 19, 2021. Applications submitted after this date will be added to the bottom of the list once the lottery is held.

Triad Associates has been designated by the Township of Cinnaminson to act as the program Administrative Agent to qualify and assist homebuyers through the application process. <u>Units will be deed restricted to ensure continued affordability</u>. <u>Applicants will be required to have a minimum credit score of 640 (with no recent judgments, bankruptcies or foreclosures) in order to obtain mortgage preapproval.</u> When you are next on the list and a unit is available you will be contacted and provided with a list of lenders that work with the specific deed restrictions of these properties.
